This technical bulletin is to notify healthcare facilities of minor changes to the form for Application, Medical Clearance, and Certification for Emergency Admission of an Allegedly Mentally III Person to a Mental Health Facility. The updated version is dated 4/23/18 in the footer of the form.

Similarities to prior forms:

- Statutory definition of mental illness (NRS ٠ 433A.115)
- Indication the individual is mentally ill and danger to self and/or others
- Check box for circumstances and written description of behaviors
- Authorized person's signature
- Reference to medical screening prior to admission ٠ (NRS 433A.165)
- Name/signature of person performing the medical examination
- Certification the individual meets (NRS 433A.115)
- Certification to release/discharge the individual
- Name/signature of person authorizing release/discharge
